OVERVIEW:

The Maryland State Lottery Agency ("Lottery" or "Maryland Lottery"), is giving Lottery players a chance to win lots of great Baltimore Ravens ("Ravens") merchandise and experiential prizes simply by entering the Extra Yards code, an 11-digit code ("code"), and the number of yards found under the Extra Yards section of your *Ravens Cash Fantasy* scratch-off ticket (Game #788) at mdlottery.com/ravens. More than \$600,000 worth of Ravens Cash Fantasy prizes ("Fantasy Prizes"), which include Ravens merchandise and Ravens experiential prizes, will be awarded throughout this promotion!

The Lottery will conduct frequent drawings for Fantasy Prizes throughout the Ravens Cash Fantasy Internet Promotion ("Internet Promotion") until the announced end of game. The first time you visit mdlottery.com/ravens to enter the code and Extra Yards from your *Ravens Cash Fantasy* scratch-off ticket, you will be required to register by creating a player profile where you will be able to enter your Extra Yards and accrue them until you have enough to enter the drawing(s) of your choice. (Players and winners are sometimes referred to as "you", "your" and "participant" or "participants"). A drawing is any random selection event. **Internet access and e-mail address are required to enter Extra Yards. Mailed entries will not be accepted.**

There are ten (10) Fantasy Prize prize categories, each requiring a specific number of yards to enter. All drawing dates for each prize category will be announced at mdlottery.com/ravens as they are determined. See below for more information.

RAVENS CASH FANTASY PRIZE CATEGORIES and EXTRA YARDS REQUIRED FOR EACH PRIZE CATEGORY:

Ravens Season Tickets for Life*: 300 Extra Yards

The Ravens Season Tickets For Life prize includes one (1) pair of Club Level II tickets and a seasonal parking pass, to be delivered to the winner annually for the winner's life, up to twenty (20) years, beginning with the 2010 football season. In the event of an NFL lockout and/or a player strike, the Ravens Season Tickets for Life prize shall be extended such that the winner shall receive tickets for the same number of games as games missed as a result of any such lockout(s) and/or player strike(s), in the same seats represented by the Personal Seat License ("PSL") and for the next consecutive game(s) in the season(s) immediately following the last season originally scheduled for the Ravens Season Tickets for Life prize. The PSL remains the property of the Lottery. The drawing date for the Ravens Season Tickets for Life* prize is TBD and will be announced at mdlottery.com/ravens.

Ravens Season Tickets for Life is a prize for the life of the winner, up to twenty (20) years, that will be delivered to the winner annually beginning with the 2010 football season. In the event of the winner's death, any remaining seasons on the Ravens Season Tickets for Life prize will revert back to the Lottery. The Ravens Season Tickets for Life* prize is not transferable or assignable.

Ravens Season Tickets for One Season: 200 Extra Yards

Ten (10) pairs of Ravens Season Tickets for One Season ("Season Tickets") - one (1) pair of 2009 Season Tickets and **nine (9) pairs** of 2010 Season Tickets - will be awarded in nine (9) separate drawings. Each pair of Season Tickets includes one (1) pair of Season Tickets in Zone D (low rows) and a Seasonal Parking Pass for that season. The drawing date for the one (1) pair of 2009 Season Tickets will be announced at mdlottery.com/ravens at the beginning of the Ravens Cash Fantasy Internet Promotion. The drawing dates for the remaining eight (8) pairs of 2010 Season Tickets, will be announced at mdlottery.com/ravens as they are determined.

Luxury Skybox Tickets for One Game (Entire Suite of 24 Tickets): 150 Extra Yards

Two (2) winners in two (2) separate drawings will each win a private Luxury Skybox for 24 people (winner plus 23 guests) to a regular season Ravens game during the 2009 season. Food and beverages will be provided for all Luxury Skybox Tickets. All drawings and their respective game dates will be announced at mdlottery.com/ravens as they are determined.

NEW - 2010 Luxury Skybox Tickets for One Game (Set of 6 Tickets): 130 Extra Yards

A total of twenty (20) winners - four (4) each for five (5) 2010 regular season Ravens games - will win a set of six (6) tickets plus a parking pass to one of the following home games: Cincinnati, Pittsburgh, Cleveland, Miami or New Orleans. Food and beverages will be provided for all Luxury Skybox Tickets. Final Entry Deadline is February 8, 2010, 12 noon.

Luxury Skybox Tickets for One Game (One Pair of Tickets): 100 Extra Yards

A total of twelve (12) winners - six (6) each in two (2) different drawings - will win one pair of Luxury Skybox tickets to a regular season Ravens game during the 2009 season. Food and beverages will be provided for all Luxury Skybox Tickets. All drawings and their respective game dates will be announced at mdlottery.com/ravens as they are determined.

Away Trip With the Team: 100 Extra Yards

Ten (10) Away Trips ("Trip" or "Trips") for two (2) with the Team to the 12/27/09 Ravens Away Game against the Pittsburgh Steelers will be awarded in ten (10) separate drawings. Each of the ten (10) Trips for two will include travel on the team plane from Baltimore-Washington International Thurgood Marshall Airport to and from the destination, one meal for winner and guest on each flight, two (2) game tickets to the destination football game, ground transportation to and from the hotel, ground transportation to and from the game, and one (1) double occupancy room in the team hotel in the destination location for one (1) night, and \$250 in spending money. Any guest of winners must be at least 18 years of age.

For all Trip prizes, the Trip does not include: mileage, insurance, gratuities, meals unless so provided, parking fees, departure fees, excess baggage fees, alcoholic beverages (other than those served without charge at any reception and/or party provided by the Ravens), any items not expressly specified, and personal expenses such as telephone calls, valet service, laundry and the like, as well as (unless incurred by an act or omission of the Ravens) revision or cancellation fees which may be charged by the hotel or other supplier. Trip Prize winners must retain both their Claim form and instructions for confirming their airline travel and any submissions deadlines. The Ravens will provide Trip Prize winners with a complete itinerary and the necessary information needed when checking in at the airline terminal specified for the team plane. Travelers (Trip Prize winners and guests) will be bound by and agree to abide by all laws governing in the relevant travel. Trip Prize winners should understand that air travel is subject to forces beyond the control of the Lottery.

Ravens Training Facility: 70 Extra Yards

Ten drawings will be conducted to award ten (10) players a tour for two (2) at the Ravens Training Facility. The tour, scheduled for 12/16/09, will include the opportunity to watch the Ravens during a regular season practice plus lunch, and a meet-and-greet with Coach Harbaugh and a Ravens athlete. All drawings will be announced at mdlottery.com/ravens, but only the next drawing will be announced at any one time. Any guest of the winners must be at least 7 years of age.

Premium Single Game Club Seat Tickets (One Pair): 50 Extra Yards

A total of **38 pairs** of Premium Single Game Club Seat tickets - four (4) pairs to each of the first two (2) regular season home games, and five (5) pairs to each of the remaining six (6) regular season home games, for the 2009 season - will be awarded in eight (8) separate drawings. All drawings will be announced at mdlottery.com/ravens.

Game-Worn Jerseys: 25 Extra Yards

A total of **twenty-five (25)** winners - selected in a series of drawings - will win a Game-Worn Jersey worn by a Baltimore Ravens football player. All drawings will be announced at mdlottery.com/ravens, but only the next drawing will be announced at any one time.

Autographed Footballs: 50 Extra Yards

Twenty-five (25) winners - selected in a series of drawings - will win an Autographed Football signed by a key player. All drawings will be announced at mdlottery.com/ravens, but only the next drawing will be announced at any one time.

Autographed Ravens Photographs: 10 Extra Yards

A total of **three hundred (300)** winners - in a series of drawings - will win an Autographed Ravens photograph. The Autographed Ravens photographs will be of key players. All drawings will be announced at mdlottery.com/ravens, but only the next drawing will be announced at any one time.

Actual prizes may vary, depending upon availability.

Entries for the Ravens Cash Fantasy Extra Yards Internet Promotion will be accepted at any time beginning August 10, 2009 through 8 AM of the final entry date for the last drawing ("Internet Promotion period"). Entry deadlines for each drawing will be announced at mdlottery.com/ravens. The Ravens Season Tickets for Life* drawing and certain others will be announced at a later date at mdlottery.com/ravens. Entries for each drawing must be registered by 8 AM on the announced drawing date to be eligible for that drawing. It is the player's responsibility to determine when those dates are.

HOW TO ENTER:

To enter the Ravens Cash Fantasy Internet Promotion, visit the Lottery website at mdlottery.com/ravens or go to mdlottery.com and click on the link for the Ravens Cash Fantasy Internet Promotion. You will be directed to either register and create a player profile if you are a first-time user or to login to your account. If you are a first-time user, you will be required to provide your Email Address, Name, Address, Phone Number (and, optionally, mobile phone number), and to create a Password. **Internet access and e-mail address are required to enter Extra Yards. Mailed entries will not be accepted.** Once you create or login to your account, you will be required to enter the 11-digit code and the number of Extra Yards, both found under the Extra Yards portion at the bottom right corner of your *Ravens Cash Fantasy* Scratch-Off ticket. **The Extra Yards on your ticket may come from winning or non-winning Ravens Cash Fantasy scratch-off tickets (Game #788).**

You can choose to accumulate your Extra Yards by entering them in your personal account or you can enter them in the drawing(s) of your choice once you have accumulated the number of yards you need for entry into a given drawing. Once your entry has been correctly registered, you will be automatically taken to the "My Codes" screen which lists all the codes you have entered to date. Once your yards have been correctly entered into a drawing, you will receive an on-screen message acknowledging entry into that drawing and you will automatically be sent an email message acknowledging entry into that drawing. **You must be 18 years or older and must have a legal presence in the United States to enter.**

Entries into any drawings are final. Once an entry(s) has been designated for a specific drawing, it cannot be changed. You will be sent a confirming email each time you designate your Extra Yards for a specific drawing. Please be sure to allow "do-not-reply@mdlottery.com" as an approved address in your email account, so you receive relevant email messages regarding this Internet Promotion.

Only the 11-digit code with the accompanying number of Extra Yards from Maryland Lottery *Ravens Cash Fantasy* Scratch-Off tickets (Game #788) will be eligible for entry into the *Ravens Cash Fantasy* Internet Promotion drawings. Registration of qualified *Ravens Cash Fantasy* Scratch-Off tickets at the Lottery's website is the only method of entry into the drawing, and each 11-digit code from a *Ravens Cash Fantasy* Scratch-Off ticket is eligible for entry only once. Your entered Extra Yards will be stored in your Player Profile until assigned to a drawing. Each of your Extra Yards is eligible for entry in, and to win, only one drawing. Extra Yards entered into drawings for the following prize categories/prizes will remain in the pool of entries for that prize category or prize, unless selected as a winner, until the final drawing for that prize category or prize has occurred: Autographed Ravens Photographs, Autographed Footballs, Game-Worn Jerseys, Season Tickets for One Season for the 2010 Season, Ravens Training Facility, and Away Trip With the Team. However, entries must be registered by 8 AM on the announced drawing date to be eligible for that drawing. Once an entry is selected as a winner, that entry will be removed from the pool of eligible entries.

From time to time, you may be given limited opportunities to win promotional Extra Yards. These promotional Extra Yards can be entered into your Ravens Cash Fantasy Internet account and applied towards any Ravens Cash Fantasy Prize drawing once you accumulate the number of yards needed for a given drawing. However, to be eligible for and to win any Fantasy Prize, you must have purchased at least one *Ravens Cash Fantasy* Scratch-Off ticket (Game #788) and registered it in your Internet account at mdlottery.com/ravens.

CLAIMING:

All winners of the Ravens Cash Fantasy Internet Promotion drawings will be notified via telephone and/or e-mail and/or certified mail to confirm eligibility. **You will be advised, at the time of notification, of claiming procedures and claiming deadlines.** Winners of the Ravens Season Tickets for Life, Season Tickets for One Season, Luxury Skybox Tickets for One Game (Entire Suite and Single Pair), Away Trip with the Ravens, Ravens Training Facility Prize, Premium Single Game Club Seat Tickets, Game Worn Jerseys and Autographed Footballs must claim their prizes in person at the Maryland Lottery Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230. Winners of the Autographed Photographs may claim your prize in person or through the mail by sending a completed claim form with the required information to the address in the sentence above.

All winners must complete a Lottery Claim Form, including Social Security number (SSN), and must provide proof of your SSN and must furnish photo I.D. proof of being at least 18 years of age. Allow a minimum of 15 business days after the Lottery receives a claim for delivery of any prizes other than the prizes to events with a specific date.

Ravens Season Tickets for Life*: Claiming Deadline TBD
Season Tickets for One Season for 2009 Season: The final Entry deadline is by 8 AM, September 4, 2009. Claiming deadline TBD; however, the claiming deadline will be earlier than September 10, 2009, and winner may be required to attend a claiming event. Winner will be advised of the claiming deadline at the time of notification.
Season Tickets for One Season for 2010 Season: Winners must claim their prize by 4:30 PM within 60 days after the drawing date or an alternate may be selected.
Luxury Skybox Tickets for One Game (both Entire Suite and Single Pair): Winners must claim their prize by 4:30 PM at least 2 business days prior to the event or the prize will be forfeited and an alternate will be selected. Alternates will have until the last business day prior to the event to claim their prize.
Away Trip with the Team: Winners of the Away Trip With the Team must claim their prize by 4:30 PM on December 9, 2009 or an alternate may be selected. Alternates must claim their prize by 4:30 PM on December 11, 2009. Any guest of the winners must be at least 18 years of age.
