# RAVENS CASH FANTASY

EXTRA YARDS INTERNET PROMOTION

Official Rules and Conditions of Eligibility

## OVERVIEW:

The Maryland State Lottery Agency ("Lottery" or "Maryland Lottery") is giving Lottery players a chance to win lots of great Baltimore Ravens ("Ravens") merchandise and experiential prizes, \$10,000 CASH prizes and \$1 Million CASH simply by entering, at [mdlottery.com/ravens](http://mdlottery.com/ravens), the 11-digit ticket Extra Yards code ("Code"; plural, "Codes") and the number of yards found under the Extra Yards section of your Maryland Lottery *Ravens Cash Fantasy* scratch-off ticket (Game #899) ("Ticket") beginning August 6, 2011. More than \$700,000 worth of Ravens Cash Fantasy Extra Yards prizes ("Fantasy Prizes"; individually, "Fantasy Prize"), which include Ravens merchandise, Ravens experiential prizes, \$10,000 CASH prizes and \$1 Million CASH, will be awarded throughout this promotion!

The Lottery will conduct frequent drawings for Fantasy Prizes throughout the Ravens Cash Fantasy Extra Yards Internet Promotion ("Internet Promotion") until the announced end of game of the Ticket. The first time you visit [mdlottery.com/ravens](http://mdlottery.com/ravens) to enter the Code and Extra Yards from your Ticket, you will be required to create a Personal Account, where you will be able to enter your Extra Yards and accrue them until you have enough to enter the drawing(s) of your choice. (Players and winners are sometimes referred to as "you" and "your"). A drawing is any random selection event. **Internet access and email address are required to enter Extra Yards Codes. Mailed entries will not be accepted.**

For each drawing: Entries must be entered for a specific drawing by 8 AM Eastern Time on the announced drawing entry deadline date to be eligible for that drawing. (In these Rules, all times are Eastern Time.)

## Membership Levels

In addition, players will be able to qualify for certain Membership Reward Levels ("Levels"; singular, "Level") based on the total number of Extra Yards entered. There are three Levels: PRO, ALL PRO, and HALL OF FAME. Once you qualify for a given Level, you receive the rewards for that Level every time you enter your Extra Yards. Each Level includes the rewards for any Levels before it. The three Levels, their rewards, and the number of Extra Yards you must earn to qualify are:

### PRO: 300 Or More Extra Yards

For each entry submitted, you will receive an entry into a weekly drawing for a Ravens Cash Fantasy Prize Pack. Weekly drawings will take place every Thursday throughout the promotion with the exception of Thanksgiving week. That drawing will take place on Tuesday, November 22, 2011. Qualifying entries must be submitted by 8 AM of the drawing entry deadline date.

### ALL PRO: 1,000 Or More Extra Yards

Each time you enter a drawing, you will get a second entry into that same drawing for free. You will also still receive the reward of the PRO Level.

### HALL OF FAME: 5,000 Or More Extra Yards

Each time you enter your Extra Yards, the number of Extra Yards you are entering will automatically be doubled. You will also still receive the rewards of the PRO and ALL PRO Levels.

**You must be 18 years or older to enter. All winners and guests must be at least 18 years of age.**

## FANTASY PRIZES:

There are sixteen (16) Fantasy Prize prize categories, each requiring a specific number of yards to enter. All entry deadline dates for each Fantasy Prize prize category ("Prize Category") will be announced at [mdlottery.com/ravens](http://mdlottery.com/ravens) as they are determined. PRIZE CATEGORIES and EXTRA YARDS REQUIRED FOR EACH PRIZE CATEGORY:

**NEW PRIZE! – \$1 Million CASH:** 300 Extra Yards

The entry deadline date for the \$1 Million CASH prize is TBD and will be announced at [mdlottery.com/ravens](http://mdlottery.com/ravens).

**Ravens Season Tickets for Life\*:** 300 Extra Yards

The Ravens Season Tickets For Life\* prize includes one (1) pair of Club Level II tickets and a seasonal parking pass, to be delivered to the winner annually for the winner's life, up to twenty (20) years, beginning with the 2012 football season. In the event of a lockout and/or a player strike, the Ravens Season Tickets for Life\* prize shall be extended such that the winner shall receive tickets for the same number of games as games missed as a result of any such lockout(s) and/or player strike(s), in the same seats represented by the Personal Seat License ("PSL") and for the next consecutive game(s) in the season(s) immediately following the last season originally scheduled for the Ravens Season Tickets for Life\* prize. The PSL remains the property of the Lottery. The drawing entry deadline for the Ravens Season Tickets for Life\* prize is TBD and will be announced at [mdlottery.com/ravens](http://mdlottery.com/ravens) when it is determined. Estimated Prize Value: \$216,000

Ravens Season Tickets for Life\* is a prize for the life of the winner, up to twenty (20) years. In the event of the winner's death, any seasons up to twenty years associated with the Ravens Season Tickets for Life\* prize will revert back to the Lottery. The Ravens Season Tickets for Life\* prize is not transferable or assignable.

**Ravens Season Tickets for 2012:** 200 Extra Yards

Ten (10) pairs of Ravens Season Tickets for 2012 ("Season Tickets") will be awarded in a series of drawings. Each pair of Season Tickets includes one (1) pair of Season Tickets in Zone D, a Seasonal Parking Pass for that season, and \$100 worth of Ravens Bucks. **\*\*NEW PRIZE! Ravens Cheerleader Calendar Trip:** 180 Extra Yards

Two (2) winners will each win a Ravens Cheerleader Calendar Trip ("Cheerleader Trip"; plural, "Cheerleader Trips") for two for the player and one guest to an exciting beach resort in the Bahamas to join the Ravens Cheerleaders and 98 Rock for the 2012 Spring Fling and calendar shoot. Each of the Cheerleader Trips for two will include roundtrip airfare for two, one (1) double-occupancy room for five (5) days and four (4) nights in the hotel where the Ravens Cheerleaders stay for the trip, meet and greet with the 2012 Ravens Cheerleaders, on-air interview with 98 Rock Morning Show, an autographed calendar upon release by all in the calendar, and all meals including food and beverages (winners can purchase an upgraded dining package at winners' own expense), plus \$1,000 in spending money. **NEW PRIZE! – \$10,000 Cash:** 100 Extra Yards

Eight (8) winners will win a \$10,000 cash prize, one each in a series of eight (8) weekly drawings. The drawings will take place every Thursday beginning 12/15/11 through 2/2/12. One winner will be selected for each drawing. You must enter each drawing individually to be included in that drawing. Drawing entry deadlines for each drawing will be announced at [mdlottery.com/ravens](http://mdlottery.com/ravens). Prize Value: \$10,000 each

**\*\*ENHANCED PRIZE! – Away Game Trip With the Team: 100 Extra Yards**

Ten (10) Away Game Trips (“Game Trip” or “Game Trips”) for the winner and one guest with the Team to the Ravens Away Game scheduled for December 4, 2011 against the Cleveland Browns will be awarded in a series of drawings. Each of the ten (10) Game Trips for two will include travel on the team plane from Baltimore-Washington International Thurgood Marshall Airport to and from the destination; one meal for winner and guest on each flight; two (2) best available single game tickets to the destination football game; ground transportation from airport to hotel, hotel to game, game to hotel, hotel to airport; and one (1) double occupancy room in the team hotel in the destination location for one (1) night; plus \$500 in spending money. Every winner and guest will also be provided with pre-game hospitality and an activity or reception. Winner and guest must have no drug conviction and no felony conviction. \*\* The terms “Trip Prize” and “Trip Prizes” include the Cheerleader Trips and the Game Trips. All Trip Prizes do not include: mileage, insurance, gratuities, meals unless so provided in these Rules, parking fees, departure fees, luggage fees, alcoholic beverages (other than those served without charge at any reception and/or party provided by the Ravens), any ground or other transportation not expressly specified in these rules, any other items not expressly specified, and personal expenses such as telephone calls, valet service, laundry and the like, as well as (unless incurred by an act or omission of the Ravens) revision or cancellation fees which may be charged by the hotel or other suppliers. Trip Prize winners are responsible for payment of these amounts.

Trip Prizes may not be sold. Trip Prizes may not be used by anyone other than the prize winner without the Lottery Director's written approval. All drawings will be announced at [mdlottery.com/ravens](http://mdlottery.com/ravens). Watch for continuing announcements.

Any portions of a Trip Prize missed shall be forfeited. You should understand that air travel and other modes of travel, and football games are subject to forces beyond the control of the Lottery and the Ravens, and therefore, the Lottery and the Ravens shall not be subject to any liability as a result of the inability to fulfill the Trip Prizes or any portion thereof. You further understand and agree that the Lottery reserves the right in its sole discretion a) to substitute a prize of equivalent value for any Trip Prize in the event that circumstances warrant this change, (estimated cash value of the Cheerleader Trip is Six Thousand Dollars; estimated cash value of Game Trip is Eight Thousand Dollars), or b) to reschedule the fulfillment of the Trip Prize. Winners may not request a substitute or equivalent prize.

Trip Prize winners must retain both your Claim form and instructions for confirming your airline travel and any submissions deadlines. The Ravens will provide Trip Prize winners with a complete itinerary and the necessary information needed for checking in at the airline terminal specified for the team plane or at the otherwise designated airline terminal. Travelers (Trip Prize winners and guests) will be bound by and agree to abide by all laws governing the relevant travel. Trip Prize winners should understand that air travel and other modes of travel are subject to forces beyond the control of the Lottery.

The five (5) Ravens home games are: 10/16/11 vs. Houston Texans, 10/30/11 vs. Arizona Cardinals, 11/20/11 vs. Cincinnati Bengals, 11/24/11 vs. San Francisco 49ers, and 12/11/11 vs. Indianapolis Colts. **Private Away Game Viewing Party at M & T Bank Stadium: 80 Extra Yards**

One (1) winner plus nineteen (19) guests will have the opportunity to watch a Ravens away football game in a private suite, on the stadium Jumbotron at M&T Bank Stadium during a Ravens away game against the Pittsburgh Steelers on November 6, 2011. Food and beverages will be provided. Winner and guests will also have the opportunity to receive a tour of the Stadium, including locker room and field access. The drawing entry deadline will be announced at [mdlottery.com/ravens](http://mdlottery.com/ravens) when it is determined. Estimated Prize Value: \$3,500

**NEW PRIZE! – Ravens Alumni Breakfast: 70 Extra Yards**

Five (5) winners plus one (1) guest each will participate in an Alumni breakfast with a former Ravens player at the Ravens Training Facility. Also included is a tour of the Facility with the former Ravens player plus an item autographed by the former Ravens player (former Ravens player TBD). The drawing entry deadlines will be announced at [mdlottery.com/ravens](http://mdlottery.com/ravens) as they are determined. Estimated Prize Value: \$1,250 each

**Framed Autographed Jerseys: 60 Extra Yards**

The Lottery will give away a minimum of twenty (20) Framed Autographed Jerseys in a series of drawings. Each Framed Autographed Jersey will be signed by a Baltimore Ravens football player. All drawing entry deadlines will be announced at [mdlottery.com/ravens](http://mdlottery.com/ravens). Watch for continuing announcements. Estimated Prize Value: \$825 each

**ENHANCED PRIZE! Premium Single Game Day Package Tickets (one pair): 50 Extra Yards**

Twenty (20) winners will each receive a pair of Premium Single Game Club Level Seat tickets to one 2011 season home game – four (4) pairs available to five (5) regular season home games. Each winner will also receive a parking pass, and an escorted on-field visit for winner and a guest, plus \$100 in Ravens Bucks. The five (5) Ravens regular season home games are: 9/11/11 vs. Pittsburgh Steelers, 10/2/11 vs. New York Jets, 10/16/11 vs. Houston Texans, 11/20/11 vs. Cincinnati Bengals, and 12/11/11 vs. Indianapolis Colts. **NEW PRIZE! - Autographed Standard Authentic Helmets: 50 Extra Yards**

The lottery will give away a minimum of twenty (20) Autographed Standard Authentic Helmets in a series of drawings. (Important: Helmets do not contain regulation padding and are not intended to be worn. *Helmets are not safe to wear.*) Each Helmet will be signed by a key player and presented in a case. All drawing entry deadlines will be announced at [mdlottery.com/ravens](http://mdlottery.com/ravens). Watch for continuing announcements. Estimated Prize Value: \$419 each

**Autographed Footballs: 20 Extra Yards**

The Lottery will give away a minimum of twenty-five (25) Autographed Footballs in a series of drawings. Each Autographed Football will be signed by a key player and presented in a case. All drawing entry deadlines will be announced at [mdlottery.com/ravens](http://mdlottery.com/ravens). Watch for continuing announcements. Estimated Prize Value: \$375 each

**Autographed Photos: 10 Extra Yards**

The Lottery will give away a minimum of twenty-five (25) Autographed Ravens photographs in a series of drawings. Each Autographed Ravens photograph will be of a key player. All drawing entry deadlines will be announced at [mdlottery.com/ravens](http://mdlottery.com/ravens). Watch for continuing announcements. Estimated Prize Value: \$50 each

Actual prizes may vary, depending upon availability. This is a bonus game and these are bonus prizes.

**Entries for the Ravens Cash Fantasy Extra Yards Internet Promotion will be accepted at any time beginning 12 AM August 6, 2011 through 8 AM of the final drawing entry deadline date for the last drawing (“Internet Promotion period”).**

**Entry deadlines for each drawing will be announced at [mdlottery.com/ravens](http://mdlottery.com/ravens). Entries for each drawing must be entered for a specific drawing by 8 AM on the announced drawing entry deadline date to be eligible for that drawing. It is the player’s responsibility to determine when those dates are.**

**HOW TO ENTER:**

To enter the Internet Promotion, visit the Lottery website at [mdlottery.com/ravens](http://mdlottery.com/ravens) or go to [mdlottery.com](http://mdlottery.com) and click on the link for the Internet Promotion. You will be directed either to create a Personal Account if you are a first-time user or to login to your account if you already have one. If you are a first time user, you will be required to provide your Name, Address, email address (and, optionally, Phone Number and/or mobile phone number), and to create a Password. **Internet access and email address are required to enter Extra Yards Codes. Mailed or hand-delivered entries will not be accepted.** Once you create or login to your account, you will be required to enter the 11-digit Code and the number of Extra Yards, both found under the Extra Yards portion at the bottom left corner of your Ticket. **You may enter Extra Yards on your Ticket from winning or non-winning Ravens Cash Fantasy Scratch-Off Tickets (Game #899).**

You can choose to accumulate your Extra Yards by storing them in your Personal Account or you can enter them in the drawing(s) of your choice once you have accumulated the number of yards you need for entry into a given drawing. Once your entry has been correctly entered, you will be automatically taken to the “My Codes” screen which lists all the Codes you have entered to date. Once your yards have been correctly entered into a drawing, you will receive an on-screen message acknowledging entry into that drawing and you will automatically be sent an e-mail message acknowledging entry into that drawing.

Entries into any drawings are final. Once an entry(s) has been designated for a specific drawing, it cannot be changed. You will be sent a confirming e-mail each time you designate your Extra Yards for a specific drawing. Please be sure to allow “do-not-reply@mdlotteryravens.com” as an approved address in your e-mail account, so you receive relevant e-mail messages regarding this Internet Promotion.

Only the Code with the accompanying number of Extra Yards from a Maryland Lottery Ravens Cash Fantasy Scratch-Off Ticket (Game #899) will be eligible for entry into the Internet Promotion drawings. Entry of valid Codes and Extra Yards at the Lottery’s website is the only method of entry into

the drawing, and each Code from a Ticket is eligible for entry only once. Your entered Extra Yards will be stored in your Personal Account until assigned to a drawing. Each of your Extra Yards is eligible for entry in, and to win, only one drawing.

Extra Yards entered into drawings for the following prize categories/prizes will remain in the pool of entries for that Prize Category or prize, unless selected as a winner, until the final drawing for that Prize Category or prize has occurred: Season Tickets for 2012, Away Game Trip With the Team, Ravens Alumni Breakfast, Framed Autographed Jerseys, Autographed Standard Authentic Helmets, Autographed Footballs, and Autographed Photos.

Entries for all other prizes and prize categories (\$1 Million CASH, \$10,000 CASH Prizes, Ravens Season Tickets for Life\*, Ravens Cheerleader Calendar Trip, Ravens Cave, Ravens Skybox for One Game, Ravens Hospitality Tent, Private Away Game Viewing Party at M & T Bank Stadium, and Premium Single Game Day Package Tickets), will be entered in the selected single drawing and will not be in a pool.

**You can enter your Ravens Cash Fantasy Extra Yards Code and Extra Yards at any time throughout the Internet Promotion period. However, entries must be entered by 8 AM on the announced drawing entry deadline date for the specific drawing to be eligible for that drawing.** Once an entry is selected as a winner, that entry will be removed from the pool of eligible entries.

From time to time, you may be given limited opportunities to win promotional Extra Yards. These promotional Extra Yards can be entered into your Personal Account and applied towards any Fantasy Prize drawing once you accumulate the number of yards needed for a given drawing.

You may enter as often as you like; however, for these five Prize Categories: the Ravens Season Tickets for 2012, Cheerleader Trip, Ravens Cave, Game Trip, and Ravens Alumni Breakfast, you may only win once per Prize Category. Any duplicate entry drawn within any one of those Prize Categories will be disqualified and considered invalid. Even if you have won Season Tickets for 2012 and/or the Cheerleader Trip and/or the Ravens Cave and/or the Game Trip and/or the Alumni Breakfast, you may still win any of the Fantasy Prizes outside of these five prize categories more than once, provided you are at least 18 years of age and your entry can be confirmed as a valid entry (as required for all entries and winners). This Internet Promotion is governed by these Official Rules and Conditions of Eligibility ("Rules"). By participating in the Internet Promotion, you agree to be bound by these Official Rules and Conditions of Eligibility.

The Lottery reserves the right to reschedule any times and dates regarding this Internet Promotion, if necessary, without advance notice.

#### **CLAIMING:**

All winners of the Internet Promotion drawings will be notified via telephone and/or e-mail and/or certified mail to confirm eligibility. The Lottery, in its sole discretion, may choose to use additional or alternate means or methods to notify the winners. **You will be advised, at the time of notification, of claiming procedures and claiming deadlines.** Winners of the \$1 Million CASH, \$10,000 CASH prizes, Ravens Season Tickets for Life\*, Ravens Season Tickets for 2012, Cheerleader Trip, Ravens Skybox for One Game, Ravens Cave, Game Trip, Ravens Hospitality Tent, Private Away Game Viewing Party at M & T Bank Stadium, Ravens Alumni Breakfast, Framed Autographed Jerseys, Premium Single Game Day Package Tickets, Autographed Standard Authentic Helmets, and Autographed Footballs must claim your prize in person at the Maryland Lottery Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230. Winners of the **Autographed Photos** may claim your prize in person or through the mail by sending a completed claim form with the required information to the address in the sentence above.

**You do not need to keep or present the Ticket or the Extra Yards portion of your Ticket in order to claim your prize if you win.** However, only one name can be entered for a winning entry. If there is more than one name for a winning entry, only one name will be used and the Lottery will choose which name is the winner, in the sole discretion of the Lottery. Prizes must be claimed by 4:30 PM of the claiming date. If any prize is not claimed by the claim date, winner will forfeit the prize and an alternate winner may be selected, whether specifically noted below or not.

All winners must complete a Lottery Claim Form, including Social Security number (SSN), and must provide proof of your SSN and must furnish photo I.D. proof of being at least 18 years of age. Allow a minimum of 15 business days after the Lottery receives a claim for delivery of any prize other than the prizes to events with a specific date.

All winners are responsible for all taxes, including income taxes. All required estimated applicable state and federal taxes will be withheld from the \$1,000,000 prize and the \$10,000 prizes. If you owe child support or certain other debts to a State agency or other governmental entity, any amount that would have been applied on your behalf as estimated tax withholdings or provided as a cash prize or the cash portion of any prize will be applied to your unpaid child support and/or to certain other debts owed to a State agency or other governmental entity. Those amounts will be added to your reportable income. You will be taxed on those amounts. **If you are a winner of a merchandise Fantasy Prize with a value over \$5,000, the Lottery will pay the required estimated State and Federal tax withholdings on that Fantasy Prize; however, if you owe child support or certain other debts to a State agency or other governmental entity, then you must pay those outstanding debts in order for the Fantasy Prize to be awarded to you. If any of those outstanding debts are not paid off within five (5) business days of claiming any prize for which the Lottery will pay the tax withholdings, then an alternate winner will be selected.** Further amounts may be owed. You will receive a W-2G form for any prize won with a value greater than \$600.
